

“PIXMA ANYTHING” PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter, prizes and gifts form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter.
3. Promotion commences at 9.00am AEST on 22/04/2009 and closes at 5.00pm AEST on 31/07/2009 (“Promotional Period”). Game of skill Rounds open at 9.00am AEST on 25/05/2009 and close at 11.59pm AEST on 02/08/2009 (“Entry Period”).
4. To be eligible to claim a gift, individuals must, during the Promotional Period, purchase any one of the following PIXMA printers from any participating Australian retail store: MP240, MP480, MP540, MP620, MX300, MX320, MX330, IP3600, MX860, MX7600, IP100, MP630, MP980, MX850 or IP4600.
5. To submit a claim, claimants must visit the www.canon.com.au/PIXMA website and then follow the prompts to the competition claim page and input the requested details, during the Promotional Period.
6. After undertaking the process as detailed in condition 5, claimants will receive a confirmation pop-up screen to confirm receipt of their claim and will also be sent an email to their nominated email address. To claim a gift, all claimants must then print the confirmation pop-up screen or email and attach a photocopy of their receipt which includes proof of purchase of the selected Canon PIXMA Printer and then mail it to: **“Canon PIXMA Anything” Offer PO BOX 733, EASTERN SUBURBS MC, NSW 2004**. All claims must be received no later than last mail received on 14/08/2009 and no responsibility will be accepted by the Promoter for late or misdirected entries.
7. Once the posted purchase receipt has been validated the gift will be mailed to the address provided when submitting their entry. Claimants must allow 28 days for delivery.
8. To enter the game of skill competition, individuals must use a printer to create any output within the capabilities of the printer and take an original photo of their creation. Individuals must then upload their photo by visiting www.canon.com.au/PIXMA, following the prompts to the competition entry page, inputting the requested details and uploading their photo and submitting the fully completed entry form during the Entry Period. Uploaded files must be submitted in JPEG format and must be a minimum of 500kb and a maximum of 5mb in size.

9. The Promoter reserves the right, at any time, to;
- verify the validity of entries and claims;
 - verify the entrants and claimants (including an entrant's or claimant's identity, age and place of residence); and
 - disqualify any entrant or claimant who submits an entry or claim that is not in accordance with these Terms and Conditions or who tampers with the entry or claim process.

Errors and omissions will be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
